Maryland PTA Needs Help

The Maryland PTA Vice President for Leadership Development is coordinating the state's annual PTA Reflections Program which provides opportunities for students from preschool through grade 12 to express themselves and to receive recognition for their artistic efforts in six areas: dance choreography, film production, literature, musical composition, photography, and the visual arts. The 2011-2012 Reflections theme is "Diversity Means..."

Students participate in the Reflections Program by submitting entries to their local school PTA and those entries may progress to the county, state and national contests. Students whose entries are judged to be outstanding at the national level are eligible for prize money and national recognition. Last year's winning entries are currently on display in the U.S. Department of Education in Washington, DC.

Impartial volunteer judges are needed to evaluate the art work received in each of Maryland's six art areas. Are there members within AARSPA who might be willing to judge one or more of the art categories? Retired school personnel are perfect candidates for judges since they have worked with students, often in the specific Reflections art areas, may have had experience as elementary or secondary language arts teachers, art teachers, music teachers, photography teachers, or teachers who have taught a film study class or who worked in the drama field. There may also be retired teachers who have personal talents in musical composition or dance.

Interested members are requested to forward their name and contact information to the Maryland PTA office in Glen Burnie which will work out the details of scheduling and answer volunteers' questions. Volunteers are needed to judge during the period from February 8-18th. Judging typically takes an afternoon or so, but it can be spread out over a longer period if needed. Entries are judged on artistic merit/creativity, mastery of the medium, and, most heavily, interpretation of the theme – no special skills are needed and a rubric is provided.
