## **Support for Residents in Assisted Living Facilities**

Did you know that two thirds of nursing home residents have their entire

income taken for their care? This includes Medicare/ Medicaid, Social Security, pensions and all other income. In 1972, Congress established a personal needs allowance of \$25.00 monthly. This amount was raised to \$30.00 a month in 1987 and hasn't increased since. While family members often supply needed items, this is not always the case. Some residents have no family and even when there are family members, they are not able to help. For some residents, buying toothpaste becomes an expense that needs to be planned.

We have no way of knowing who among those residents may have impacted our lives; we know how we can impact theirs. While toiletries and resources for activates may seem a small item to you and me, it means so much to the them.

Working with the Anne Arundel County Dept. of Aging, the following locations were selected by the committee:

- Assisted Living with Compassionate Care (Millersville)
- Autumn Lake Healthcare (Crofton)

- Books, word searches, crossword puzzles, Sudoku (prefer large print but others ok)
- Puzzles (100-500 pieces) board games, (checkers, Monopoly, etc.)

- · Bingo cards and markers
- Colored Pencils, small glue sticks, double sided tape, construction paper
- Craft Supplies: acrylic paint, coloring books, Zen coloring books, paint with water coloring books, painted stones project, ribbon, popsicle sticks, buttons, pipe cleaners, markers
- Bingo prizes: small coloring books, prewrapped snacks (anything that fits in a small gift bag)
- Bird Seed: There are feeders outside the dining room.
