Salutations! We hope that you have had a wonderful summer and are ready for the excitement of fall, absent the need to return to school. We are anxious to begin our second year as co-presidents. having learned a great deal from our first year. In particular, we learned that our organization runs effectively due to the dedication of the folks that head and serve on our 30 committees. In this, our 78th year, we hope that our new retirees will join us as we continue to advocate for the concerns and interests of the retirees from the Anne Arundel Public School System.

It is important that you join us in reaching out to retirees, both recent and established, and ask them if they are members. If each of you would reach out to one fellow retiree who is not a member and invite them to join, we could easily expand our membership. The state organization, Maryland Retired School Personnel Association (MRSPA) is offering a \$10 discount through October 1, 2018, to new members for their first year of membership as well as a \$10 gift card if you recruit a new member who signs up for dues deduction. You may also get a \$10 deduction on your first year as a dues deduction member if you are currently a cash member who signs up for dues deduction.

As the Executive Board reviewed the accomplishments of this past year, there are some notable items that we would like to share. AARSPA and MRSPA representatives have advocated on your behalf with the Maryland Legislators, assuring the continued strength of the retirement and pension system. Issues of the costs of medication were also addressed with legislators, resulting in multiple bills. If you are interested in advocating for your fellow members, the Legislative Workshop, provided by MRSPA, our state association, is scheduled for November 14. Another major accomplishment was the awarding of four \$4,000 scholarships to students seeking careers in education. This was funded through the generosity of our members and \$5 of each \$15 membership fee that goes to support the scholarship fund. In addition, our members generously contributed to the Alzheimer's Walk and Sarah's House, donated books for new teacher classroom libraries, and donated to local animal shelters and the food bank. The AnneArrundell County Free School Museum is staffed by docents and opens to the public on specified weekends thanks to dedicated AARSPA



volunteers. Our musical group, Voices in Melody, has provided entertaining programs at senior centers and assisted living facilities around the county as well as at our own AARSPA meetings. Our trips committee continues to arrange educational and fun trips. The first of the trips this vear is scheduled for October 17th to the African American Museum of History and Culture. If you would like to join any of these wonderful groups or activities, please look for information at our September meeting and in future issues of the AARSPA Informer.

We have planned informative and entertaining general membership luncheon meetings for this coming year. Please treat yourself to a special lunch and time to connect with former colleagues and join us at one or more of our luncheon meetings. Our first meeting will be at Two Rivers Restaurant in Pasadena on Thursday, September 13. We are fortunate to have AACPS Teacher of the Year, Joshua Carroll, as our guest speaker.

We believe from letters of a Hopkins' descendent that the schoolmaster at the Free School may have traveled on weekends to the Hopkins' farm, which is about three miles from the school, to tutor the boys.

# NEWS YOU CAN USE

#### New Medicare cards are coming:

This year you will be receiving a new Medicare card with a number that is different from your Social Security number. (You can learn when your card will arrive by going to Medicare.gov/NewCard).

The new card is an effort to prevent fraud. However, scammers are already targeting beneficiaries by calling and demanding a processing fee. Sometimes they say there is a reimbursement from the old card. They then ask for a bank account number where they can send the money.

There is NO processing fee and there are NO refunds. NEVER GIVE ANY PERSONAL INFORMATION ON THE PHONE, THE INTERNET, IN A LETTER OR AT YOUR FRONT DOOR!

#### Increasing the life expectancy of a friend:

Who knew we had the power to increase the longevity of a friend. The latest research has described loneliness as the "new smoking." It is as bad as inhaling 15 cigarettes a day! Studies show that loneliness can shave eight years off life expectancy. CareMore, based in California, became the first health care provider to hire a "chief togetherness officer" to directly address loneliness and its impact on health.

People with close friends are more likely to get plenty of sleep, eat healthy foods, have less stress, engage in brain healthy activities, and take on new challenges or hobbies.

Is there someone you have been intending to call or invite to lunch? DO IT; it will be good for both or you.

#### **New Smoke Alarm Law:**

A new smoke alarm law went into effect January 1, 2018. It requires the replacement of battery-only alarms with new, ten year smoke alarms with sealed batteries and a "hush" feature which silences the alarm temporarily during cooking.

Hard-wired smoke alarms older then ten years must be replaced with another hard-wired alarm. You cannot replace a hard-wired with a battery-only alarm.

In the future, the law requires replacement of ALL smoke alarms when they are ten years old.
