For the safety and comfort of our guests, the Free School Museum is closed until further notice.

Did You Know?

Some time after 1878 the original stone free school building was remodeled and became a home for Stephen Beard who worked for the Maryland Public School System. In March of 1911 the Legislature sold the original property to Luther L. and Fannie McKenney. In May of 1915 the building was deeded to Benjamin F. and Bertha P. Van Horne. In September 1940, it was deeded to Myer Lynsky and conveyed to Morris Lynsky in October 1956. In September 1958, the property was conveyed to the Green Hill Company and then conveyed to Lavall, Inc., the company that built the homes in the community, in January 1974. From that point in time until now, the property has been owned by Anne Arundel County Public Schools.

2021 FLORIDA GATHERING

We want to take this opportunity to thank Arlene and Ron Derflinger for all the time, effort and work they put into the AARSPA in Florida event we had scheduled for this year but had to cancel because of the COVID-19 pandemic. 
- Akilah Curtis, Old Mill High School, will major in Education of the Deaf and Hard of Hearing at Flagler College in St. Augustine, FL.


However, as we have moved forward, there has been a big **OOPS!** moment in our local renewal campaign. First, let me explain. When the BOE closed their doors due to COVID-19, your association was closed out as well. We were unable to physically retrieve any mailings addressed to us at the Riva Road address. As responses were received and recorded, we noted the returns were low. As a result, a June reminder letter was readied and mailed.
