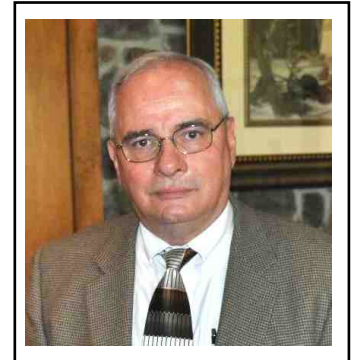

At the most recent Executive Board meeting, Dr. Maxwell and members of his executive staff were in attendance. Dr. Maxwell thanked our membership for all that we do in support of the school system and for our lifetime commitment to the children and citizens of our county. He elaborated on the challenges that the school system is facing including the budget, maintenance of effort funding, and the impact of the National Health Insurance laws. There are some serious concerns involving the matching funds from the county in order to receive State capital funding for construction, and he and his staff shared efforts being made to reach out to the business community to support the school system. It was shared that 30% of the students currently attending AACPS schools qualify for assistance through the Free and Reduced Meals Program and that the number continues to increase. He stated that the upcoming budget does not include any changes to the retirees' benefit funding, but that as the guideline for the National Health Insurance laws are clarified, there may

be implications in 2014. He closed with an invitation for us to re-establish an on-going dialogue throughout the year.

It is going to be very important that you keep abreast of the pension legislation being presented in the Maryland legislature this year. There is an emphasis to switch from the corridor funding to actuarial funding of the pension, and we join MRSPA is supporting this legislation. If you go to our website, or the MRSPA website, you will find links to the action taking place in both the State House and Senate. It is very important that you share your thoughts with your legislators, and the easiest way to do that is through email. In the past I have never been very politically active but have become increasingly so since I have come to realize that they do read and respond to our emails, letters and calls. It has amazed me how little some of our legislators know about our pension, health care benefits, and other matters that impact retired educators.



I am pleased to inform the membership that just before the holidays, and through your generosity, AARSPA was able to deliver to the Judy Center at Hilltop Elementary \$215 along with clothing and books for the pre-schoolers in that program. Thank you for your support of this community service effort.

I am looking forward to traveling down to Naples, Florida to join our members in the Sunshine State at the 22nd Florida Get-Together on February 21 and 22. I want to thank Joanne Hogan and her folks for making the arrangements. Joanne will open her house for what has proven to be a fun time of sharing experiences and laughter and I look forward to the luncheon at the Forest Glen Country Club. I hope to see many of you in Naples for this event.

CONSUMER EDUCATION

Items to Take to the Emergency Room

First, take along some identification and your insurance card. It is important for the hospital to properly identify you.



You should have a list of important phone numbers, including your work number, family contacts (next of kin) and your neighbors. Having a personal preloaded cell phone will save time and effort.

You should have a listing of all doctors, with their accurate name and address. The hospital may want to send any records they develop of your stay to your doctors.

Have a list of all medications with dosages you are taking. The hospital may need to give you different drugs and it is important that they do not conflict with what you are already taking.

Bring along a credit card to pay the copayment and deductible, and a little cash and coins for vending machines. Don't bring along too much that you would be overly concerned if lost.

NEWS FROM THE TRIP COMMITTEE

LEGISLATIVE UPDATE



The Maryland General Assembly began the 2013 session on January 9th. For the first time since the recession began we are not in crisis mode. The economic outlook in Maryland is slowly, but steadily, improving.

Our primary focus this year is to secure the Maryland State Retirement and Pension System (MSRPS) by returning to actuarial funding. The "corridor method" was instituted ten years ago as a way to reduce the amount that the state had to put into the budget for our pensions. Actuarial funding is an accepted accounting practice where the amount is based on statistical calculation of the true or actual cost. Corridor funding is a made up term that legislators have been using to identify the method described in the legislation passed in 2002.

The Joint Pensions Committee has introduced legislation (SB474/HB496 State Retirement and Pension System – Funding Method and Amortization of Unfunded Liabilities or Surpluses) to phase out the corridor method over a ten year period and return to actuarial funding. **Now is the time. Please contact your legislators to ask them to support these bills.** For more information on these bills or how to contact your legislator, go to www.mrspa.org.

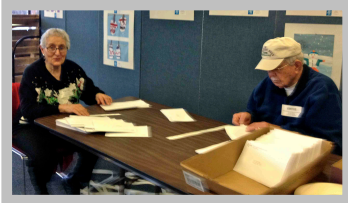
