CONSUMER UPDATE

News you can use:

Home

Don't throw away those unused herbs. Place them in the individual compartments of an ice cube tray. Cover the herbs with water, broth, olive oil or butter and freeze. Once they are frozen, remove from the tray, place in a plastic container, and return to the freezer. Simply remove the cubes from the container when you want to add herbs to a favorite recipe.

Money

Always review your credit card statements each month and be on the lookout for a new scam. Apparently, scammers know we will notice a large charge but expect us to ignore a small one. The latest is called the "\$9.84 scam" because that is the amount they steal. Always call the credit card company to get clarification on any charge you don't remember placing. Besides, for the interest they charge, they can answer our questions even if it turns out we simply forgot the purchase.

Your phone rings and caller ID shows an 876 area code. While this appears to be coming from the U.S., it is a Jamaican area code and very often scammers. They can be very persistent, and have been known to threaten to harm victims if money is not sent.

If you believe you have been scammed on a phone call, contact the carrier with whom the charge originated, whose name should be printed on the same bill as the charge in question. Often, the problem can be resolved with a single phone call.

Health

Research has shown that one's social network is more important than exercise when determining one's life expectancy. This is not to suggest one should quit exercising. However, getting involved in volunteering and social activities is essential. LEGISLATIVE UPDATE



The Maryland General Assembly is back in session and, as expected, requires our attention. After ten years of "Corridor Funding", our pension fund was at a serious low of 63% funded. Legislation was passed in the 2013 Session that would, among other things, return us to "actuarial funding". The agreement was that the state would put in an additional \$300,000,000 so that the pension fund would reach full actuarial funding by 2024. The final 2013 budget held out \$100,000,000 to balance the budget, moving the acceptable level of funding out one more year.

This year the Governor's Budget calls for an **ongoing funding shortfall of \$100,000,000**. The funding ratio of the MSRPS is at approximately 64.5%. Actuarial standards for public pensions consider a funding ratio of 80% or higher as necessary for maintaining a healthy system that can meet long term liabilities and responsibly manage market volatility.

As presented, the Governor's Budget states the following: SB 172/HB161
BUDGET RECONCILIATION AND FINANCING ACT OF 2014
"30 Article – State Personnel and Pensions
For fiscal year **2014 and each fiscal year thereafter** ...the Governor shall include in the budget bill [\$300,000,000] **\$200,000,000**."

Clearly, reducing the State's share by \$100,000,000 is unfair and a violation of the intent of the legislation passed in 2013. Most importantly, we cannot allow the words "...each fiscal year thereafter..." to stand. This would continue to push back the achievement of a funding ration of 80% another year, every year.

Opponents include MRSPA, MSEA, State Treasurer Kopp, State Comptroller Franchot, and Lt. Governor Brown. MRSPA has sent a letter to the Governor, the Senate President, the Speaker of the House, committee chairs, and other legislative leaders stating our concerns related to this proposal.

We must be certain that our legislators hear from us – members. Phone calls, visits, letters are all excellent. You can also go to the MRSPA web site. The "TAKE ACTION" tool located on the member page makes this process easy and convenient. Members may send the letter provided there or create their own.

Attend the AARSPA Legislative Luncheon on March 5th, from 11:00 a.m. to 1:00 p.m. in Room 180 of the Lowe House Office Building.

Understand that our pension benefits are secure. However, the state must honor its commitments to current and future retirees with the promised adequate funding. The proposed budget may raise red flags once again with rating agencies that evaluate the state's debts, unfunded liabilities, and commitments to pension sustainability.
