As I sit down to compose state aid under the this article, it looks like we have dodged another winter storm. Our hearts go out to our friends in New England who keep getting the brunt of this winter weather. It is just the beginning of February, so there is still plenty of time for us to receive a punch from "old man winter." Hopefully, our luck will not run out!

I would like to start out with some good news! As you know. Governor Hogan is now in office, and the State Legislature is now in session. Despite a deficit of \$750 million, the budget proposed by Governor Hogan includes the full actuarial funding of the Pension/Retirement Trust Fund as well as the \$150 million "catch-up" amount promised by the the downside, the proposed budget calls for significant cuts to educational funding to local boards of education. This is of concern partially due to our health care benefits. I have heard that Anne Arundel county schools could lose as much as \$15 million in

proposed cuts. It is important that AARSPA work closely with the AACPS Benefits Office, Superintendent, and Board of Education to ensure that our health care benefits are not ieopardized.

We need to keep a close eye on what unfolds in Annapolis as they toy with and mid-April. Currently, the teacher portion of the Agency is nearly 70% funded. Be sure to check the "Legislative Update" on the MRSPA website to stay informed about legislation important to us. Contact information for our legislators is available on and Secretary of the this website as well. MRSPA encourages each of us to contact our Legislators by e-mail Legislature last year. On messages, phone calls, letters, and attendance at hearings. The new Legislature includes 68 first-time members, five of them representing districts in Anne Arundel County. We need to educate our new delegates as to our stands on the issues that services for older adults. they will be voting on.



On January 28, 2015, eight AARSPA members this budget between now attended the United Seniors of Marvland Legislative Forum in Maryland State Retirement Annapolis. We had the opportunity to hear from Lt. Governor Boyd Rutherford, Speaker of the House Michael Busch. President of the Senate Mike Miller. Comptroller of the State of Maryland Peter Franchot, Department of Aging Rona Kramer. Much of the discussion at this Forum dealt with health care concerns for seniors. It was pointed out that there are now more senior citizens than school-aged children in the state of Maryland. There was a lot of information shared on aging in place, selfsupporting "Villages", and




SCHOOL DAYS

Our primary concern for so many years has been the preservation and improvement of our pension system. For the second year in a row, we have earned over 14% on our investment returns, well above the yearly goal of 7.7%. We are now funded at 68%, a 3% improvement over last year.

The first stop on this latest AARSPA adventure will be at the Hotel Du Pont, modeled after the great hotels of Europe, in downtown Wilmington, Delaware's legal and financial district! Participants will enjoy a delicious buffet luncheon served amidst the hotel's elegant furnishings and signature artwork! Next, we will depart for Longwood Gardens, one of the premier botanical gardens in the United States. Longwood Gardens consists of over 1,077 acres of gardens, woodlands, and meadows in Kennett Square, Pennsylvania, in the Brandywine Creek Valley. With flowering trees, spring annuals such as pot marigolds and snapdragons, native azaleas, columbines, Virginia bluebells, and foam-flowers bursting into bloom, spring blooms create a symphony of color like no other season. For those who may have difficulty walking the grounds, carts are available at the site for a cost of \$25.00 on a first come, first serve basis. However, there is no quarantee that carts will be available by the time we arrive.

NEWS YOU CAN USE

Have you been a victim of identity theft or a scam? If not, you probably know someone who has had fraudulent charges on their credit card, been taken in by a con artist, or had their identity stolen. According to the consumer protection branch of AARP, every two seconds someone's identity is stolen. Listed below are some of the most common scams currently occurring in Maryland, as well as easy ways to make it more difficult for con artists to victimize us. At the end are some useful websites.

Phone Calls:

Someone identifying themselves as representing a local bank, church, business or medical facility calls you at home. They provide you with just enough information to convince you they are legitimate. This information may have been gotten from your trash, your office, or from social media websites. It may also have been taken from your mailbox. Now it will be used to steal your identity.

After convincing you they are credible, they ask for additional information. They may even provide some inaccurate information such as your Social Security number and ask you to verify it. When you correct their information, you have provided them with enough information to apply for credit cards in your name.

Stolen Passwords:

Millions of user names and passwords for Facebook, Twitter, Google, banks, stores, medical facilities, among others, are compromised and sold to scammers each month. These are then used to make purchases and clean out bank accounts. How secure are your passwords?

Consider the following ways to make your passwords harder to crack:

Avoid words that are in dictionaries. There are programs that can crack passwords by going through a database of known words. One trick is to think of a sentence and use just the first letter of each word.

Avoid your name, company name, hometown, zip code, and birthdays. These can easily be found in easily accessible sources of information.

Change passwords frequently. It's possible your account information is already circulating. If you have a regular schedule for changing passwords for major accounts, you reduce the amount of time that someone can do harm with that information

Use combinations of letters and numbers, upper and lower case, and symbols. Try to vary it as much as you can. "MyPaSsWoRd 32" is better than "mypassword32.

To reduce your vulnerability to identity theft:

Do not carry your Social Security card in your wallet or print it on a check.

When paying bills by check, place the envelope in a blue mailbox instead of the box at your house.

Shed or tear up credit card receipts, bank statements, and credit card offers.

Check credit card statements and bills for unauthorized charges.

Obtain a copy of your credit report each year. Maryland residents are entitled to one free copy of their report from each of the three major credit-reporting agencies each year. (Equifax: 800-685-1111; Experian: 888-397-3742; and Trans Union: 800-888-4213)
