## Historic Cape May, New Jersey Wednesday, May 15, 2019



Today we escape to the charming seaside city of Cape May, New Jersey. Upon our arrival, we enjoy a delicious lunch of either Mahi Mahi or Southern Grilled Pork Chop at **The Washington Inn**. ## **NEWS YOU CAN USE**

As we prepare for winter, it is good to review safe driving tips. These are recommendations from AAA.



- 1. Accelerating, stopping, and turning take longer and are less predictable when the pavement is covered with snow and ice. Drivers underestimate how long it can take to brake. Maintain a slow and constant speed. Don't use cruise control; you need to be prepared for the unexpected.
- 2. Modern cars with anti-lock brakes require you press hard on the pedal and let the car do the work of slowing down. The pedal will vibrate as each individual brake pulses, providing enough traction and stability to help you maneuver around obstacles. Stopping on ice requires twice the distance as on a dry pavement.
- 3. All-wheel drive and four-wheel-drive cars won't stop any faster than a standard car if you hit a patch of ice.
- 4. Don't stop on ice or snow if you can avoid it. Approach stoplights and signs by slowing from a distance. Maintain a slow and even speed even when going up hills. Reduce your speed before starting down a hill. Also, consider shifting into a lower gear.
- 5. Make sure the gas tank is at least half full and the wiper fluid tank is filled. Check that your headlights are clear and wiper blades are in good order. During the winter months, carry a hat, gloves, shovel, and blanket in the car even in clear weather.
- 6. If you are stuck in the snow, check the exhaust pipe. If the pipe is blocked and the motor is running, deadly and odorless carbon monoxide will enter the car. Just to be safe, keep a window cracked.

Annearrundell County Free School Museum
(placed on the National Register of Historic Places by the U.S.
Department of the Interior on June 16, 1983)

Even though our 2018 Open House season is over, the Free School Museum is open by appointment for individual or group tours. Contact Karlie Everett (karlieeverett@verizon.net or 410-268-8656) to arrange for a tour.

During these late fall and winter months, we give tours to school groups, scout groups, and Sunday school groups with a school marm teaching lessons as the

lessons would have been taught in the 1700's and 1800's. We also give tours to adult groups such as Red Hat Ladies, sororities, community college classes, and to adults who are interested in the



history of education in Anne Arundel County. Tours are designed to meet the interests of the individuals and groups arranging the tours.

The new roof for the Free School Museum is completely finished. Why not come by and see it for yourself!

Did You Know? The Annearrundell County Free School was one of 12 schools created by the Maryland Free School Act of 1723. It was the county's first school paid for with taxpayers' money. The taxpayers' money was used for the purchase of the land and the building of the school with suitable quarters for a schoolmaster. Tuition was charged to attend the school. Students were usually boys; girls usually did not attend school during this time period.


