From the Free School Museum

Did You Know?

We teach lessons to our student-guests as the lessons might have been taught in the 1700's and the 1800's. Have you ever wondered how we do this? Below is a brief overview of how we teach lessons from the 1700's.



We start by talking about the

benches in the original 1723 room. There was no need for desks because books and paper were expensive and not always available. The Bible was used for reading. A sand table was used to practice letters and writing.

We talk about the three uses for the fireplace heat, cooking, and light - and we also talk about the use of candlelight. Candles were seldom used because they, too, were expensive, especially bayberry candles. When candles were used, they were used with great care. There were no fire companies nearby.

We start the day with Recitation. However, there is no Pledge of Allegiance because it wasn't written until 1892 almost 170 years after 1723. For young guests, we recite the letters of the alphabet.

We begin our Ciphering lesson by reminding students there were no calculators. There might have been an abacus, but most math was done by memorizing. We do skip counting and mental math and word problems with the students.

We take a lunch break and talk about the lunch pails; students usually had tobacco tins or molasses tins. We talk about things students would've eaten and not eaten for lunch. Students in the 1700's had to recycle and eat Farm to Table.

We talk about discipline and share the Dunce Caps. We discuss how your sibling would most likely be in the same classroom, so your parents were sure to hear about any of your misbehaviors.

We then have an Elocution lesson, usually doing a few tongue twisters and memorizing a poem.

We conclude our lessons with a Spelling Bee.

Carolyn Webber, who also sings in the AARSPA Chorus, most often teaches these activities with students. If you are interested in watching a lesson, please let us know. We will let you know when we have a field trip scheduled.

News You Can Use

It's tax time!

Did you know AARP will complete and file your tax return FOR FREE?

While their website indicates they focus on individuals over 50 years old with low to moderate income, they will work with anyone, even the 18 year old filing their taxes for the first tax time. There are some exceptions. Those include self-employment with employees, and losses or expenses more than \$25,000.00. Also, they will not file when there are complicated capital gains or losses. There are some other complicated situations that are described on their website.

Individuals can schedule an in-person appointment by visiting the AARP website and selecting a location. Sites are available throughout the state and specific locations should be posted by early January. All volunteers have undergone over three months of training and are IRS certified to prepare the taxes.

Is your car ready for winter?

While we have had brief periods of cold days the worse is yet to come. Make sure your car is ready for those cold and snowy days. AAA recommends the following ways to prepare your car for winter. Take your car to your service center and request a winter checkup. They should do the following.

- Check the tire pressure
- Check the battery charge and remove any corrosion
- Replace worn wiper blades
- Check the level of the coolant

You should also maintain a full to nearly full gas tank to prevent the gas lines from freezing.

Of course the best winter safety advice is to leave the car in the garage and stay home with a good book. There are many advantages to being retired.

Going Green

Dues Deduction / Switch and Save

MRSPA is able to deduct New or Switch and Save member dues any month. Dues deduction files are sent to the Maryland State Retirement Agency (MSRA) on/by the 6th of each month. MRSPA receives the deduction report from the state on the 30th of each month and 10 days to two weeks later, local treasurers should receive their payment checks. Dues are still deducted only once ANNUALLY, per membership year.

Please consider making this change to your membership where your dues are automatically deducted. You won't need a reminder letter; you won't be cancelled from both the state and the local; and you will be informed of all activities by receiving your newsletters.
