The air is crisp! We are beginning to see pumpkins, gourds and mums everywhere we go! It won't be long before the leaves begin to turn beautiful colors. Time flies, and fall is here – enjoy this beautiful season!

We held our first luncheon for the 2014-15 year at La Fontaine Bleu on Thursday, September 11<sup>th</sup>. There were 120 members present, including three emeritus members and eleven "first-timers". After observing a moment of silence for those Americans who were killed as a result of the terrorist acts of that day thirteen years ago, we started our business portion of our meeting. We had a packed agenda which was highlighted by a presentation of "AARSPA from the Heart" – our renewed effort to place more emphasis on community service activities. Phyllis Cherry and Karlie Everett are the co-chairs of this committee. Along with Carla Duls, our historian, they presented our plans for the year. I am happy to report that through the generosity of our members, we collected four boxes of school

supplies. It is my understanding that the items collected will be given to the children who attend Marley Elementary School. There was also a collection of toiletries that will be taken to a senior living facility. There were also representatives from Arlington Echo, the AVID program, and "Success in Style" seeking volunteers to assist with their programs.

Susan Baugher, from the Benefits Office at the Board of Education, came to speak to our membership about health care benefits for 2015. The good news is that there will be no increases in retiree healthcare premiums for 2015. Healthcare funding will remain at 75% for the medical and dental options. **There will be a prescription benefit change for retirees and dependents who are Medicare-eligible which will become effective on January 1, 2015.** The new prescription plan will be administered through CVS Caremark SilverScript. Those retirees and their spouses who are over 65 will automatically be enrolled through Medicare Part D prescription benefits **(no action is required on your part)**. Medicare Part D will be primary RX

coverage and AACPS standard plan will provide secondary coverage. Prescription co-payments will remain the same.

Please see your benefits package that you recently received in the mail for further information regarding this change. **It is strongly suggested that you ignore the "opt out" letter that you will receive from SilverScript prior to your enrollment. Should you "opt-out", both medical and prescription drug coverage for you and your dependents will be terminated.**

Our next Business Meeting/Luncheon will be held on Thursday, November 6<sup>th</sup>, 2014 at the Center of Applied Technology-North. This

## FREE SCHOOL NEWS



In mid-August, a group of AARSPA members (Carla Duls, Tony Anzalone, Charlie Gable, Barry Fader, Phyllis Cherry, Alicia Hardisky, Mary Dunlap, and Karlie Everett) participated in another unpacking and repacking of the artifacts that were being stored in the Free School Museum attic. The artifacts were from the 1978 archaeological dig that took place as part of the restoration and renovation of the building. During this second artifacts unpacking and repacking gathering, we discovered a snuff bottle, a piece of a slate, a slate pencil, and plaster from 1725.

A final unpacking/repacking event took place at the end of September with AARSPA members Tony Anzalone, Phyllis Cherry, Barry Fader, Mary Dunlap, Bob Kanach, and Karlie Everett participating. The next step is to compare the artifacts without a provenance number to the remaining items in the archeological dig catalog.

This exciting historical project could not be completed without the tremendous work of our AARSPA members. We would also like to thank Kate Dinnell who currently works at the MAC Lab in Calvert County. Kate was an archaeologist on one of the original digs at the Free School Museum. She has been donating her time to this effort helping and guiding us on her days off from work.

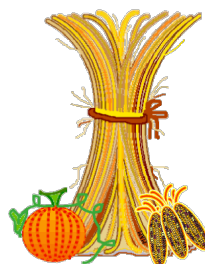

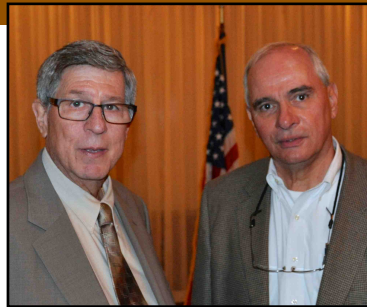

# NEWS YOU CAN USE

For those of you who do Fall house cleaning, the following housekeeping tips will even save you money.

- The refrigerator can be one of the least energy-efficient appliances. Vacuum the coils (located along the front bottom or in the back) about twice a year to remove any dust or dirt and save 30% annually.
- The dust on a dirty light bulb can absorb up to 50% of the light it's emitting, causing you to switch on another lamp in the room, doubling your electricity usage. Rub cooled-off bulbs with a damp cloth once a month.
- A soiled stove can be an energy pit. Keeping the interior, range top burners and reflectors clean can save up to 10% by redirecting heat more efficiently, warming food faster and more evenly.
- You can add five years to the life of your mattress by vacuuming it once a season to eliminate dust mites, bacteria and allergens. To further deodorize, mix 1 cup baking soda with a few drops lavender essential oil in a jar, and shake well. Sprinkle the mixture over the mattress and let it set for an hour. This will draw any moisture or dirt to the surface. When finished, vacuum up the excess.
- Dryer blockages cause the machine to work 50% to 75% harder. Clean the lint trap after every load by pulling out the screen and brushing with a dry cloth. Clothing fibers or dryer sheets can also coat the moisture sensor electrodes (two parallel metal strips along the inside wall of the machine), throwing off the damp-to-dry measurement and producing an under dried load. Wipe off the sensors with the scrubber side of a dry sponge once a season.

## All Hail The Great Pumpkin!

Jack-o'-lanterns are the symbol of Halloween, but don't overlook pumpkin as a source of nutrition. Pumpkins are loaded with vitamin A and fiber, and low in calories. Other fruits and veggies that are inexpensive buys for Fall months are squash, apples, beets, cabbage, sweet potatoes and swiss chard. Pair these up with a simple rotisserie chicken for a healthy, nutritious and inexpensive meal that is quick to prepare and so good for you!
